**VARSITY AND SUB VARSITY  
INTERNATIONAL STUDENT WAIVER FORM**

**(Good for three consecutive sports seasons beginning with student's first varsity season)**

International student waivers will be acted on by the appropriate league. The CHSAA office will act on waivers for international students from independent schools. All waivers must be approved prior to participation and will be good for three consecutive sports seasons beginning with student's first varsity season. (See CHSAA Handbook for more details.) Programs monitored by the Council on Standards for International Travel (CSIET) and approved by the NASSP will be mailed to member school athletic directors each year for informational purposes only. Students on CSIET programs or other international exchange programs shall be approved by the league. For international students and refugees in NO program, league and CHSAA approval is required. **Only students who hold F-1 or J-1 visas, or who have been classified by the Department of Homeland Security identifying them as a refugee, shall be considered for athletic eligibility. See by-law 1870.1 for more information.**
