YOU MUST REGISTER ONLINE AT WWW.ARBITERSPORTS.COM IN ORDER TO COMPLETE YOUR CHSAA REGISTRATION AND BE ELIGIBLE TO DO GAMES.

For payment, you have the option of filling out this form and returning it by mail with your check payment or paying online with a credit card. Youu can use a credit card for a nominal fee by going to www.chsaa.org/officials/baseball and pay using the Paypal link. Due to switching providers for payment in the arbiter, you will not be allowed to use an E-Check this dues season. We will be updating in July and next season you will again have that option, sorry for the inconvenience.

Sending your dues promptly assures that your varsity and playoff eligibility will be maintained for the 2016-2017 season. (Subject to your local Area policy).

YOU MUST HAVE A VALID (WITHIN THREE YEARS) CBI BACKGROUND CHECK ON FILE WITH CHSAA FOR YOUR REGISTRATION TO BE ACCEPTED. IF YOU HAVENT HAD A BACKGROUND CHECK SINCE 2013 YOU WILL NEED TO GET ONE ON THE ARBITER IN ACCOUNT 103372. NO OTHER FORMS OF BACKGROUND CHECKS WILL BE ACCEPTED SO PLEASE DO NOT PAY FOR AN OUTSIDE COPY.

YOU ARE REQUIRED TO REGISTER ONLINE!! YOU WILL NOT SHOW PAID IN THE CHSAA SYSTEM UNTIL YOU REGISTER ON THE ARBITER. TO DO THIS YOU NEED TO LOG INTO THE ARBITER, SIGN INTO GROUP 104529, CLICK ON THE LINK IN THE MIDDLE OF THE PAGE THAT SAYS "CLICK HERE TO RE-REGISTER", ANSWER ALL THE QUESTIONS TO THE PAYMENT PAGE. AT THAT POINT, MARK THE CHECK OPTION WHETHER PAYING ON PAYPAL OR CHECK AND I WILL FINISH THE REGISTRATION FOR YOU WHEN I GET YOUR PAYMENT.
