COLORADO BOARD #4 dues for the 2017-2018 seasons are now due.

YOU MUST REGISTER ONLINE AT WWW.ARBITERSPORTS.COM IN ORDER TO COMPLETE YOUR CHSAA REGISTRATION AND BE ELIGIBLE TO OFFICIATE.

For payment, you have the option of filling out this form and returning it by mail with your payment or paying online with an e-check or credit card. The e-check is only available through ArbiterSports. Go to www.arbitersports.com and login to Account 104526 and click on the Re-register link. Follow the directions to the end and pay your dues with an e-check by providing your checking routing and account number. There is a .75 cent cost for the transaction and you save by paying on or before APRIL 15. As in the past, you can use a credit card for a nominal fee by going to http://www2.chsaa.org/officials/basketball/o_basketball.asp and pay using the Paypal link. **YOU WILL NOT SHOW AS PAID UNTIL YOU HAVE REGISTERED IN THE ARBITER. THIS ONLY EFFECTS THOSE WHO CHOSE TO USE PAYPAL AND CHECK. IF YOU PAY ON ARBITER, MAKE SURE YOU LET ME KNOW YOUR DUES ARE PAID.**

Sending your dues promptly assures that your playoff eligibility will be maintained for the 2017-2018 season.

YOU MUST HAVE A VALID (WITHIN THREE YEARS) CBI BACKGROUND CHECK ON FILE WITH CHSAA FOR YOUR REGISTRATION TO BE ACCEPTED. IF YOU HAVENT HAD A BACKGROUND CHECK SINCE 2014 YOU WILL NEED TO GET ONE ON THE ARBITER IN ACCOUNT 103372. NO OTHER FORMS OF BACKGROUND CHECKS WILL BE ACCEPTED SO PLEASE DO NOT PAY FOR AN OUTSIDE COPY.

Your dues breakdown includes \$35 for IAABO, \$17 for National Federation, \$10 for CHSAA and \$33 for the operation of Colorado Board #4. Please refer to the CHSAA website to review the entire 2017 budget and the prior year's actual income and expenses.
