CFOA dues for the 2017-2018 seasons are now due.

YOU MUST REGISTER ONLINE AT [WWW.ARBITERSPORTS.COM](http://WWW.ARBITERSPORTS.COM) IN ORDER TO COMPLETE YOUR CHSAA REGISTRATION AND BE ELIGIBLE FOR GAMES. YOU MUST HAVE A VALID (WITHIN THREE YEARS) CBI BACKGROUND CHECK ON FILE WITH CHSAA FOR YOUR REGISTRATION TO BE ACCEPTED. IF YOU HAVENT HAD A BACKGROUND CHECK SINCE 2014 YOU WILL NEED TO GET ONE ON THE ARBITER IN ACCOUNT 103372. NO OTHER FORMS OF BACKGROUND CHECKS WILL BE ACCEPTED SO PLEASE DO NOT PAY FOR AN OUTSIDE COPY.

For payment, you have the option of filling out this form and returning it by mail with your payment or paying online with an e-check or credit card. The e-check is only available through ArbiterSports. Go to [www.arbitersports.com](http://www.arbitersports.com) and login to Account 104520 and click on the Re-register link. Follow the directions to the end and pay your dues with an e-check by providing your checking routing and account number. This will have a .75 cent convenience charge. As in the past, you can use a credit card for a nominal fee by going to [www.chsaa.org/officials/football](http://www.chsaa.org/officials/football) and pay using the Paypal link.

Sending your dues promptly is one step towards maintaining your varsity and playoff eligibility for the 2017-2018 season. (Subject to your local Area policy).
