CASO dues for the 2016-2017 seasons are now due.

YOU MUST REGISTER ONLINE AT WWW.ARBITERSPORTS.COM IN ORDER TO COMPLETE YOUR CHSAA REGISTRATION AND BE ELIGIBLE TO OFFICIATE.

YOU MUST HAVE A VALID (WITHIN THREE YEARS) CBI BACKGROUND CHECK ON FILE WITH CHSAA FOR YOUR REGISTRATION TO BE ACCEPTED. IF YOU HAVENT HAD A BACKGROUND CHECK SINCE 2013 YOU WILL NEED TO GET ONE ON THE ARBITER IN ACCOUNT 103372. NO OTHER FORMS OF BACKGROUND CHECKS WILL BE ACCEPTED SO PLEASE DO NOT PAY FOR AN OUTSIDE COPY.

For payment, you have the option of filling out this form and returning it by mail with your payment or paying online with an e-check or credit card. The e-check is only available through Arbitersports. Go to www.arbitersports.com and login to Account 104527 and click on the Re-register link. Follow the directions to the end and pay your dues with an e-check by providing your checking routing and account number. There is no cost for the transaction and you save by paying on or before APRIL 30. If you chose to pay by check or by using paypal, you will need to also register in the arbiter in order to show as paid. You will register until you get to the payment page and then you will mark the check option instead of paying and then I will complete your registration when I get your payment. As in the past, you can use a credit card for a nominal fee by going to www.chsaa.org/officials/SWIMMING and pay using the Paypal link.

Sending your dues promptly assures that your varsity and playoff eligibility will be maintained for the 2016-2017 season.

You also have the option of filling out this form and returning it with your payment. HOWEVER YOU WILL STILL BE REQUIRED TO REGISTER ONLINE. **To avoid the \$20 late fee, your envelope must be postmarked BY APRIL 30, 2016.**
