YOU MUST REGISTER ONLINE AT WWW.ARBITERSPORTS.COM IN ORDER TO COMPLETE YOUR CHSAA REGISTRATION AND BE ELIGIBLE FOR GAMES. YOU MUST HAVE A VALID (WITHIN THREE YEARS) CBI BACKGROUND CHECK ON FILE WITH CHSAA FOR YOUR REGISTRATION TO BE ACCEPTED. IF YOU HAVENT HAD A BACKGROUND CHECK SINCE 2014 YOU WILL NEED TO GET ONE ON THE ARBITER IN ACCOUNT 103372. NO OTHER FORMS OF BACKGROUND CHECKS WILL BE ACCEPTED SO PLEASE DO NOT PAY FOR AN OUTSIDE COPY.

For payment, you have the option of filling out this form and returning it by mail with your payment or paying online with a credit card. You can use a credit card for a nominal fee by going to http://www2.chsaa.org/officials/volleyball/o_volleyball.asp and pay using the Paypal link.
